- IPWEA & APWEA has standards for condition ratings
- · FCM Policy development guidelines

- · Identifying Risks (Safety, Financial)
  - · Mitigating those risks with knowledge from standards
- · Know what data to pick up and how. Follow standards
- · Management of the Plan
  - Improvement Plan
- Subject Matter Experts. Know capital costs.
- Creating whole programs (capital and maintenance programs)
- · Create projects that fix existing deficiencies.
